My name is Hugo Zamora, president of the Dental Federation of the Argentine Republic and an active member of FDI. My intention is to participate in the council with the support of my association and LARO to replicate and amplify FDI policies.

I was elected and worked as WDC2018 general coordinator in Buenos Aires where we welcomed the parliament and thousands of dentists from around the world. I was a great honour for our country and continent.

In the Argentine Odontological Confederation, I have coordinated and leading the National Prevention Commission where programmes of education and prevention are aimed at the most vulnerable and unprotected sectors of our society. This programme has been recognised by FDI in the framework of WDC Madrid, for its objectives, mission, vision as well as its scope in favour of Oral Health.

In our country i had the job of coordinating and leading, we are about to settle an agreement with 23 provinces in order to reduce the use of mercury. As part of our commitment to oral health, and health in general, we have signed agreements regarding data contribution and consultation forums with the Argentine Cardiology Association and the National Diabetes Society as part of our engagement to supporting the contention and visibility of non-communicable chronic diseases.

I had an active participation in the reconstitution of LA, ensuring that FDI policies were included in the internal operations of the associations

In times of pandemic when the world was paralyzed and our profession suffered directly, it was necessary to make decisions and assume the leadership of health professionals in the face of the confusion that arose.

In my presidency I had to take the initiative to protect our associates of the national dental confederation and all the dentists of the country who were unprotected. It was crucial to develop protocols of attention with temperance and leadership so as to lead the return to the clinics and assume the defence of work.

In 2022, I led the organization and coordination of the "Symposium of prevention and new technologies", summit of Latin American leaders, where we presented regional projects on oral cancer and HMI (MOLAR INCISOR HIPOMINERALZATION). In addition to this, I took part in the World Oral Health Day by coordinating actions in my country.

The MIH (Molar Incisor Hypomineralization) project that I have to lead from its birth to this stage of development where the calculations of dentists throughout the country are being calibrated. The most ambitious project by size that is remembered on the continent.

For the Latin-American Regional (LARO), my candidacy represents an opportunity. I know about Latin-American countries' issues.

My participation in the Council would contribute with a clear vision not only of the problems our colleagues face but it would become an opportunity to introduce feasible solutions in accordance with our countries' idiosyncrasies.

Each participant country in Latin-American Regional (LARO) has a leading role in the growth and progress, in the art and science of odontology. Together we have managed to gather efforts and exchange positive experiences to enable us to have a relevant role in the global oral health.

I am committed to aligning the forces of all the Latin-American countries with the aim of developing and strengthening the programmes and policies of the Regional Oral Health.
