A. Personal Statement

I have extensive experience mentoring students and junior faculty across several institutions in Colombia during my academic career at the Pontificia Universidad Javeriana (PUJ), Colombia. I am also a visiting Professor of several universities in Colombia and Latin America. My research focuses on the intersections between political science, economics and public health, to improve or maintain the health conditions of populations. In coordination with interdisciplinary research groups, I have developed a research program in different Colombian territories with the participation of researchers from the United States of America, Germany and Spain. For more than 30 years, I have been working on the preparation and coordination of research and consulting projects in public protection policies, especially in the following areas: Research on public policies and financing of health services, which allowed analysis in the formulation, implementation and evaluation of the health sector. Evaluation of health policies in terms of structure, processes and results with application of analysis methodologies in: Health service delivery system (installed capacity, organization and financing); Population at risk (predisposition, capacities and needs); Environment (social and economic); access made (utilization and satisfaction); Health risks (environment and behavior): effectiveness, equity, efficiency, production and allocation. The research work that has an interdisciplinary approach that includes health, environment, ethnic studies, among other areas of knowledge. I have skills and competences in mixed methods (qualitative-quantitative). I have also received training in impact assessment, disease burden estimation and road safety. The research program at the Institute of Public Health at the PUJ has been built on the accumulated capacities and experiences in the generation of public health knowledge over the years and is a flexible scenario to respond to the emerging needs arising from social transformation.

In addition to the contributions above, I have also participated as a principal and co-researcher in burden of disease studies which are a great alternative to the usual morbidity and mortality studies, the identification of risk factors for communicable diseases, because in addition to setting priorities for health services (both preventive and treatment) and establishing research priorities, they identify disadvantaged groups to guide cost-effective health interventions, enable evaluation and planning of sector interventions, plans and programs. The results of burden of disease studies have been used by governmental and non-governmental agencies to set priorities for research, development, policy and funding for health investment. In terms of extreme maternal morbidity and mortality, this is a public health priority in Colombia, not only because it is a determinant of the level of development achieved in the country and is included in the millennium goals and objectives, but also because it has been considered as such in the technical and regulatory developments of the national public health policy adopted in Colombia in recent years.
