

Dear Enzo,

I write to declare my sincere wish to be a candidate for Council during the election at the World Dental Parliament in Istanbul, Turkey in September this year.

I served as the FDI CE Programme Director for Asia Pacific from 2007 to 2016. During the ten-year period, I had organized over 120 regional CE events supporting more than 350 speakers. I collaborated with nearly 20 dental companies, dental associations & non-profit entities to fund these events. When I started in 2007 in my role, there was no funding available for me to organize any CE events. However, I managed to have raised more than 250,000 CHF for all the activities over the years. When I completed my term in 2016, I had left a surplus of over 50,000 CHF for the Asia Pacific CE Account and the FDI Global CE Account.

I was elected a member of the FDI Education Committee in Poznan in 2016. In my first term serving as an elected member of the Committee, I helped the FDI to put together the scientific program for the World Dental Congress each year, monitored the regional CE programs globally, drafted a Policy Statement on "Continuing Education via eLearning", served as a member of the Vision 2030 Task Team, served as an expert member of the "Managing the Partially Dentate Patients" Project, and helped to draft the "Guidelines on Quality Education Program".

I was then re-elected to the Education Committee for a second term in San Francisco in 2019. During this term, I first became the Vice-Chair of the Committee and was then appointed the Chair by the Council. I continued to serve on the Vision 2030 Task Team as well as member of the Partially Dentate Patients Project Task Team. I also participated in new projects on Artificial Intelligence for Dentistry, and initiated the Young Dentists Forum which was launched in Sydney last year. Last but not the least, I now chair the Regional CE Task Team for the FDI Master CE Programme to be launched in June this year.

On the side of human resources, I assisted in the recruitment of our CE Programme Directors for Africa & the Middle East as well as the Editor-in-Chief of the International Dental Journal.

I am deeply passionate about the FDI and I believe I have the qualifications, experience and all the necessary leadership skills to achieve my mission to become a member of the FDI Council as I have demonstrated them in the past 17 years of my service to the FDI and in other organizations. If elected, I will continue to do my best to achieve the FDI vision of "A world with optimal oral health" and it's key missions in knowledge transfer/exchange, advocacy and innovation.
