Draft Budget 2027

Proxy Voting

Last year, proxy voting was discussed at the Open Forum, and the General Assembly authorized the Council to continue exploring this option. I invite you to refer to the accompanying report by the Chair of the Governance Task Team on pages 140-146 of the GA binder, for an update on the work undertaken and the proposals for your consideration.

Policy Statements (PS)

The final versions of the 2026 Draft Policy Statements will be made available to all members and GA participants in August, as part of the annual timeline process. In addition, same as last year and, as part of the ongoing review process by the Standing Committees, the Council will propose to the GA that some PS are withdrawn. You can find the links to those PS on the GA Webpage. At both, Open Forum 2, when we discuss the PS, and at the General Assembly B, I will recommend the GA voting members that PS are withdrawn collectively in a single motion.
